 - b. Walk in Registration on the Event day before 9am – Registration fee is RM50.00 for open category.

** T-shirt will be given according to the size stated in the registration form. No changes is allowed 2 weeks before the Event for online registration.*
2. Participants are required to bring along their government issued Identity Card, NRIC or Passport for registration and verification purposes. Participants who are under the age of 18 years old are required to fill in the parental / legal guardian consent form. For online registration, please obtain the parental/legal guardian consent form from the downloadable attachment within the online registration page. Participants who do not bring along the required materials will be disqualified from participating in this Event.
3. Participants have to collect their goodies bag on the event day before 9.00am, failing which CMM reserves the right to forfeit the goodies bag.
